# Celebrating 20 years of collective advocacy

The RRF's story began 20 years ago with the idea of creating a forum to unite the region's diverse refugee-led community organisations (RCOs) in a peer to peer network to share and compare their experiences and build a collective advocate voice for change. Our AGM in January 2020 was a great celebration, reuniting members who've played a central

We were delighted and honoured to be joined by 10 founder members, 7 former Chairpersons, 19 former Trustees, and leaders of our 'Let Us Work' and 'Skilled' campaigns and Youth Voice. And we celebrated the new generation of community mobilisers now active in the RRF through our empowerment and collective voice programmes. #### New resources for new arrivals

Back in 2014 our Stronger Families Working Group—Sazi, Jugal, Nisha, Sara and Pamela—began advocating for all newly arriving families to have information to help them adjust to unfamiliar systems, laws, social norms, expectations, rights and responsibilities around being a parent in the UK, which could prevent families being torn apart. Well, we don't give up on a good idea!. In 2020 the North East Migration Partnership commissioned us to make 'Parenting and Schools in the UK'.

44 members from 23 RCOs and 20 countries of origin dedicated 283 hours of their time to develop the content, based on what they wish they'd been told when they first arrived here. They also contributed to two further sessions on 'Looking After Your Health' and 'Laws & Life in the UK'. Members then translated the scripts into 10 languages most common to the RAS community and recorded the sessions as videos. Anyone can access and use the resources to support new arrivals. ### Promoting routes to employment

Parenting & Schools in the UK



Construction is a growing industry in the region, yet our members provided evidence of specific barriers which prevent refugees finding meaningful work in the sector. As Chair of the North East Migration Partnership's Move on & Economic Inclusion Subgroup we've championed action and worked with the DWP, Refugee Employment Network, infrastructure contractors and Gateshead College to promote bespoke training for refugees. We're really pleased to report the first 6- week ESOL for Construction Course for refugees began on 18th May! And recruitment for the second course has started.

We collaborated with the National Careers Service (North) and the North East Hong Kongers Club to develop a workshop to help people new to the region's job market understand its growth sectors, the transferable skills and qualities valued by employers and maps out pathways to gaining new skills and career-based employment. The NCS is offering the session to all refugee communities and employability projects.

We've long advocated for a levelling up of the integration support offer made to ref-

ugees granted status from asylum claims to match provision for resettled refugees. So we actively contributed recommendations about what works to the Home Office's RTOF consultation process and celebrate that our region now has one of the 4 national pilot programmes—The North East Refugee Integration Support & Employment programme (NE RISE) began delivery in November 2021. ## Testing arts based methods for social research



In October 2020 we partnered a national project run by The Open University which explored using participatory theatre methods for social research and civic

engagement. Over 12 months, 15 members took part in 11 interactive online training workshops and a weekend of face to face workshops facilitated by experts in using Forum Theatre to explore social issues. Members unpacked their experiences of discriminatory treatment in shops, on public transport, in the street and in accessing higher education and explored how they

#### **Empowering Community Mobilisers and Activists**

Since we last reported to you at our AGM in January 2020, we've welcomed a further 41 participants into our Community Action Project (CAP). It means we've supported over 100 participants since we began in delivery in June 2019. They are active in 45 RCOs across the region, 17 of which emerged during the project.

Originally from 33 countries of origin across Africa, the Middle East, South East Asia, South America and Eastern Europe they now live across all 11 Local Authority areas accepting dispersal in the North East. All share the calling to help others and are full of ideas on how to support their

communities. Our role is to help them turn those ideas into practical action, to build their knowledge, skills and confidence to be effective community advocates, and support them to increase their networks of influence.

We've empowered them through a combination of elements. We held

- over 500 1 to 1 support sessions to help them build and deliver practical action plans;
- 23 peer learning visits for participants to other RCOs to learn from their experience and see what can be achieved;
- over 100 'Learning Community' meetings for group learning on issues they identify, with key agencies attending for mutual learning. Themes included advocacy pathways in the asylum system, covid vaccinations, pathways to employment, cancer awareness, maternity provision, changes to UK asylum law
- 43 participants completed our bespoke online training designed in response to the Covid context, on how to use their evidence and be an effective Community

Advocate in online multi-agency meetings, to ensure their voices could still be heard. We also commissioned ICT training on using online tools to assess communities' needs and priorities, and on managing online security.

And we enabled them to contribute their voice to numerous consultations across the region.



We've engaged an external consultant to research what works in empowering RAS to turn their ideas to support their communities into action. We'll be sharing findings later this year.

What is a Community Mobiliser? They mobilize a community to action leading to increased empowerment and self reliance.

What is a Community Activist? A member of a community who is voluntarily working with others from that community to achieve common aims (Delivering Change)

However you define your role, we support you.

## Training front line workers

We delivered training to over 400 front line staff, including social workers, early help teams, adult social care workers, GPs, nurses, mental health practitioners in primary care networks, crisis teams, post-graduate and undergraduate students, police and grant managers. Our sessions help them gain insight into specific challenges to family resilience, mental health and healthy living faced by asylum seekers and refugees and what works in supporting them. We successfully adapted our sessions for online delivery during Covid restrictions.

Congratulations and a special thanks to our members Sazi, Suraiya, Rama, Nisha, Pako, Ellen, Rohey, Sylvia and Nawa for their excellent delivery.

Feedback demonstrates how these sessions can positively affect the way trainees engage with and support the community.
